RESOLUTION

WHEREAS, by Resolution #22-5037, dated August 18, 2022, the Board of Commissioners ("the Board") of the Memphis-Shelby County Airport Authority ("Airport Authority") approved award of a contract to General Atomics International Services Corporation, doing business as Cryotech Deicing Technology ("Cryotech"); and,

WHEREAS, the Board approved an initial one-year contract with Cryotech with four one-year renewal options, for a potential total contract term of five years; and,

WHEREAS, in order to align the contract term with other customers and to offer better pricing, Cryotech has recommended that the initial term be set for three years with two one-year renewal options, for a potential total contract term of five years; and,

WHEREAS, Airport Authority Management recommends approval;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Memphis-Shelby County Airport Authority, that Resolution #22-5037 is hereby revised to authorize the President and CEO or his designee to negotiate and execute a three-year contract with two one-year options with General Atomics International Services Corporation, doing business as Cryotech Deicing Technology, as herein described, cost to be paid from the Airport Authority's Operating Funds or a funding source identified by the CFO.

RESOLUTION

WHEREAS, by Resolution #21-4996, dated August 12, 2021, the Board of Commissioners of the Memphis-Shelby County Airport Authority ("Airport Authority") approved award of a contract to KONE, Inc. ("KONE"), for Elevator, Escalator and Moving Walkways Repair and Maintenance; and,

WHEREAS, the scope of services of the contract consists of providing a dedicated, full-time, on-site and licensed technician to perform preventative maintenance and repair services for all equipment at Memphis International Airport; and,

WHEREAS, the incidental costs in the contract are for the technician's time for preventative maintenance services, and all repairs will be completed at negotiated costs, using established hourly rates and committed discounts for the cost of parts; and,

WHEREAS, escalator #62, which is located in the economy parking structure, is currently out of service and KONE, having disassembled and inspected the escalator, has determined that the main bull gear needs replacement; and,

WHEREAS, KONE has proposed to furnish all parts and labor to complete the project for a fee of \$146,453.00; and,

WHEREAS, the scope of work includes, but is not limited to, replacement of the bull gear, replacement of damaged steps and comb teeth, replacement of the escalator step chains, installation of new handrails and rollers, and installation of new friction wheels; and,

WHEREAS, in order to allow for unforeseen conditions, Airport Authority Management recommends that a contingency of \$14,645.30 (10%) be established for the project, resulting in a total budget of \$161,098.30; and,



WHEREAS, due to the fact that this unit has been down since before Kone took over as the service provider and the fact that supply chain issues and parts delivery will take an extended period of time, management proceeded with authorizing this repair; and,

WHEREAS, Airport Authority Management recommends ratification and approval of the decision by management to proceed with authorization prior to Board action;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Memphis-Shelby County Airport Authority, that the decision by the President and CEO or his designee to award a purchase order to KONE, Inc., as herein described, is hereby ratified with cost to be paid from the Airport Authority's Operating Funds or a funding source identified by the CFO.

RESOLUTION

WHEREAS, the Memphis-Shelby County Airport Authority ("Airport Authority") is authorized by the public purchasing provisions of state law to participate in the cooperative purchasing of supplies and/or services, and, as an exception to the bidding requirements, such authority is set forth in Policy 801(7)(a) of the Airport Authority's Policy Manual; and,

WHEREAS, the Airport Authority desires to purchase one (1) CAT 930M wheel loader; and,

WHEREAS, pursuant to the State of Tennessee's Statewide Contract #225 Thompson Machinery is a current service provider and is authorized to provide wheel loaders; and,

WHEREAS, under the terms of the State of Tennessee's Statewide contract, Thompson Machinery has proposed to furnish a Model 930M wheel loader at a price of \$234,171.75; and,

WHEREAS, the price reflected above is significantly lower than list price; and, WHEREAS, Airport Authority Management recommends approval;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Memphis-Shelby County Airport Authority, that the President and CEO or his designee is hereby authorized to purchase a wheel loader from Thompson Machinery, as herein described, cost to be paid from the Airport Authority's Operating Funds or a funding source identified by the CFO.
